THIS SURVEY COMBINES TRACTS 1 AND 2 OF THE AUGUST, 2018 SURVEY, AND DESCRIBES A 1.98 ACRE TRACT IN THE SOUTHWEST CORNER OF THE COMBINED TRACTS. RAILROAD RIGHT—OF—WAY MENTIONED ABOVE IS ABANDONED. DEED EXCEPTING 6 ACRES NORTHEAST OF RAILROAD RIGHT—OF—WAY ALSO EXCEPTS ENTIRE RIGHT—OF—WAY, HOWEVER, DEED 216, PAGE 558 (RAY COWAN, ET.AL) STATES "ALL THAT PART OF THE SOUTHEAST QUARTER WHICH LIES NORTH OF THE RIGHT—OF—WAY OF THE MISSOURI, PACIFIC RAILROAD". BECAUSE OF THIS AND EXISTING PROPERTY LINES, I MARKED THE NORTH RIGHT—OF—WAY FENCE AS THE DEED AND POSSESSION LINE WITH ALL THE ABANDONED RIGHT—OF—WAY BEING POSSESSED BY THE ABOVE TRACT A. ALL CENTERS OF MARMATON RIVER POINTS REPRESENT LOCATION OF CENTERLINE OF SAID RIVER ON THE ORIGINAL SURVEY OF AUGUST 2018. PARENT DEEDS, DESCRIBE TO CENTERLINE OF RIVER SO THAT ALL CENTERLINE PROPERTY LINE IS SUBJECT TO CHANGE AS SAID RIVER CENTERLINE CAN NATURALLY CHANGE THRU TIME.
