

TRACT 2 DESCRIPTION:

A tract of land being the Southeast Quarter of the Southeast Quarter of Section 36, Township 47 North, Range 16 West of the fifth principal meridian, Cooper County, Missouri and being more particularly described as follows: Beginning at the Southeast corner of said Section 36, thence along the South line of said Section 36, North 86 degrees 17 minutes 26 seconds West, a distance of 1314.23 feet to an iron rod marking the Southwest corner of the Southeast Quarter of the Southeast Quarter of said Section 36; thence North 01 degrees 39 minutes 13 seconds East, a distance of 1340.40 feet to a stone marking the Northwest corner of the Southeast Quarter of the Southeast Quarter of said Section 36; thence South 85 degrees 49 minutes 48 seconds East, a distance of 1315.21 feet to a stone marking the Northeast corner of the Southeast Quarter of the Southeast Quarter of said Section 36; thence South 01 degrees 40 minutes 39 seconds West, a distance of 1329.80 feet to the POINT OF BEGINNING, containing 40.3 acres. Beginning at the Northeast corner of said Section 1, along the East line of said Section 1, South 00 degrees 13 minutes 54 seconds West, a distance of 1189.44 feet to an iron rod; thence North 90 degrees 00 minutes 00 seconds West, a distance of 936.49 feet to an iron rod; thence South 61 degrees 39 minutes 54 seconds West, a distance of 446.88 feet to an iron rod; thence South 00 degrees 00 minutes 00 seconds West, a distance of 436.83 feet to an iron rod; thence North 90 degrees 00 minutes 00 seconds West, a distance of 674.46 feet to an iron rod; thence North 01 degrees 01 minutes 58 seconds East, a distance of 1966.64 feet to an iron rod on the North line of said Section 1; thence along said North line, South 86 degrees 17 minutes 26 seconds East, a distance of 1977.80 feet to the POINT OF BEGINNING, containing 68.0 acres. Commencing at the Northeast corner of said Section 1, along the East line of said Section 1, South 00 degrees 13 minutes 54 seconds West, a distance of 1189.44 feet to an iron rod, said iron rod being the POINT OF BEGINNING; thence continuing South 00 degrees 13 minutes 54 seconds West, a distance of 1444.01 feet to an iron rod at the Southeast corner of said Northeast Quarter; thence along the South line of said Northeast Quarter, North 89 degrees 11 minutes 08 seconds West, a distance of 2012.47 feet to an iron rod; thence North 01 degrees 01 minutes 58 seconds East, a distance of 766.59 feet to an iron rod; thence North 90 degrees 00 minutes 00 seconds East, a distance of 674 46 feet to an iron rod; thence North 90 degrees 00 minutes 00 seconds East, a distance of 436.83 feet to an iron rod; thence North 61 degrees 39 minutes 54 seconds East, a distance of 446.88 feet to an iron rod; thence North 90 degrees 00 minutes 00 seconds East, a distance of 936.49 feet to the POINT OF BEGINNING, containing 54.8 acres.
