## **LEGAL DESCRIPTION**

All that part of United States Survey Number 2085 in Township 39 North, Range 8 East, Sainte Genevieve County, Missouri, which is described as follows, to-wit: Beginning at the most Western corner of Lot Number 2 in said Survey Number 2085, and running thence, with the North line of said Lot Number 2, North 52 degrees East 1890 feet to the place of beginning of parcel herein described; thence South 23 degrees 30 minutes East 1075 to a corner in the center of the present County Road; thence South to a corner in the center of the Establishment Creek; thence down the center of the Establishment Creek, along and with the meanders thereof to the Southeast corner of a 38.51 acre parcel heretofore conveyed to Tom Carron; thence leaving the center of the Establishment Creek, and running South 88 degrees West 4085.40 feet to a corner; thence North 38 degrees West 874.40 feet to a corner in the North line of said Lot Number 2; thence with the North line of Lot Number 2, South 52 degrees West 816 feet to the place of beginning.
